Method of Operation

A. Summary of Catered Events and/or Entertainment:

Our business offers catered events for small celebratory gatherings on our 2nd floor deck and dining room.

What: We can provide Sit down service capacity for approximately-
40 guests on the 2nd floor deck

35 guests on the 1st floor dining room

When: 11am-12am Monday-Sunday

What: Cocktail function with passed hors d'oeuvres & displayed food for approximate-:
65 guests on the 2nd floor deck

45 guests on the 1st floor dining room

When: 11am-12am Monday-Sunday

What: From time-to-time we host a dinner series with local Wineries, late night menu w/ DJ and various seminars or educational series that include keynote speaker w/ microphone set up.

Maximum capacity same as above Cocktail Function.

When: 11am-12am Monday to Sunday

- B. Approximate anticipated number of days contemplating hosting entertainment or catered affairs (35). Hours (see above). Proposed placement of seating not to change except to provide banquet style seating or food display or against the perimeter of floor plan for more circulation of guests.
- C. No stage. In-place dancing is allowed and no designated dance floors are expected. Noise mitigation include: speaker array/direction, curtained and sealable windows and doors. Management staff is present at all proposed events for security and door management.
