- a) 7 recertifications and 2 interims were performed for November 2017.

This score designates the VGHA as a "High Performer" and with such title, enables the VGHA to a reduction in reporting requirements to HUD. For example, the VGHA will be allowed to submit a PHA Plan every 5 years instead of every year. High Performing PHAs also are entitled to the full distribution of their HAP funds without penalty.

- d) A voucher was issued to a new family. Currently, there are 7 families searching for housing.
