### Item No 1. Corner of Front and Third Streets

Discussion on the application of Dan Pennessi, President of SAKD LLC. Dan Pennessi is before the Board to discuss proposed uses and development of the site located at the corner of Front and Third Streets. The Zoning Board of Appeals has granted the six variances requested to develop the proposed site.

The property is located in the WC (Waterfront Commercial) District, and the proposed uses for the site are conditional uses.

## Item No 2. 625 1st Street
