NOTICE IS HEREBY GIVEN that pursuant to Chapter 150, Zoning Article V, Section 150-27A. of the Village Code, a Public Hearing will be held by the Zoning Board of Appeals at the Third Street Fire House, Third Street, Greenport, N.Y. on Tuesday, October 18, 2016 commencing at 6:00 p.m. regarding the following applications:

Ralph and Maureen Caouette
447 Sixth Street
Greenport, NY 11944

The applicant seeks area variances to construct an open carport addition with a second floor deck to an existing dwelling.

- Section 150-12 A. of the Village of Greenport code requires a side yard setback of 15' in the R-2 district.
The proposed carport has an 8.3' side yard setback on the south property line, requiring a side yard setback variance of 6.7' in the R-2 district.
- Section 150-12 A. of the Village of Greenport code requires a 25 ft. combined side yard setback in the R-2 District.
The proposed combined side yard setback is 17.9 ft. requiring a 7.1 ft. combined side yard setback variance.

The property is located in the R-2; One and Two Family District.

The property is not located within the Greenport Village Historic District.
