NOTICE OF DEER BOW HUNTING PERMIT LOTTERY

PLEASE TAKE NOTICE that the Village of Greenport will issue permits on a lottery basis for bow deer hunting in the area of Village property known as Moore's Woods.

Applications for a permit may be obtained at the office of the Greenport Village Clerk, 236 Third Street, Greenport, New York 11944, beginning September 14, 2012. Completed applications must be returned to the Greenport Village Clerk not later than 12:00 p.m. on September 30, 2012. Applications must be returned with a copy of a valid New York State hunting license and a New York State driver license.

Permitted deer bow hunting will take place at designated stations beginning November 1, 2012 and ending on December 31, 2012. Applicants will be notified of their selection on October 1, 2012.

2. An access permit is required for hunting during the special Bow Hunting deer season.
3. Seasonal access permits are valid until December 31st.

Hunter Ethics and Waiver of Liability:

If approved to participate, I hereby agree to adhere to the hunter ethics standards below at all times while hunting or scouting in the Village of Greenport Deer Hunting Lottery:

- I will obey all hunting regulations and follow all Village of Greenport rules and procedures.
I will respect members of the public while participating in scouting and hunting activities.
I will respect the rights of other participants at all times.
I will use archery only.
I will make every effort to avoid unnecessary wounding of deer.
I will take the utmost precaution to assure the safety of others and my myself.

Assumption of Risk and Indemnification
