Application for Dumpster Permit INSTRUCTIONS

DEFINITION

Article 112-2 of the Code of the Village of Greenport:

DUMPSTER - Any container for the collection of garbage, refuse or rubbish with four (4) cubic yards of capacity or larger.

PERMITS REQUIRED

Article 112-4 prohibits any person, firm or corporation to place, put, position or situate a dumpster on any street, sidewalk or right-of-way without first obtaining a separate dumpster permit from the Building Department for each dumpster.

A dumpster permit is effective for up to 14 days and may be renewed by contacting the Building Inspector. The Building Inspector may allot a longer time period to the applicant dependent upon need.

REQUIREMENTS FOR DUMPSTERS

- A. A dumpster may be placed on or near a sidewalk, street, road, driveway or alley only if there is no alternative site near where it is needed. No dumpster shall partially or totally block any place of ingress or egress.
- B. Each dumpster shall have at least four (4) reflectors placed on each side of the dumpster. Each reflector shall not be less than three (3) inches in diameter.
- C. Dumpsters shall be properly and promptly emptied by the applicant, and under no condition shall the dumpster be filled beyond its rated capacity.

PROCEDURE

The location and use of a dumpster shall be such as to cause minimal disruption to the adjacent sidewalk, street or roadway.

Loading material into the dumpster must be done so as to minimise noise and prevent dust.

SPECIAL PRECAUTIONS FOR COMMERCIAL-RETAIL DISTRICTS AND HIGHWAYS

Where special conditions exist, such as in Commercial-Retail, General Commercial, Waterfront-Commercial Districts and where the site is on a highway or main road, it will be necessary to take extra precautions to minimise disruption.

The period that a Dumpster Permit is in effect, and/or the hours of operation may need to be restricted.

IN SOME CASES, THE USE OF WHEELED DUMPSTERS OR PORTABLE CONTAINERS INSIDE THE APPLICANT'S PREMISES AND REMOVAL BY TRUCK EARLY MORNING OR AT OTHER SPECIFIED TIMES MIGHT BE MORE APPROPRIATE THAN THE PLACEMENT OF A DUMPSTER IN THE STREET.

PERMIT CONDITIONS

A dumpster may not be placed until the issue of a Dumpster Permit.

Permits are issued on condition that work will proceed in accordance with the permit conditions.

Failure to comply with these conditions or other violation of the Code of the Village of Greenport may result in penalty under Article 112-7.

Upon violation, the permit may be revoked and the dumpster removed.
