

REQUEST FOR BIDS

PLEASE TAKE NOTICE that the Village of Greenport is seeking sealed bids only for a "2015 or newer 4 x 4 Pick-Up Truck" to be submitted at the Office of the Village Clerk, Village Hall, Village of Greenport, 236 Third Street, Greenport, New York 11944 until 4:00 p.m. prevailing time on Monday, September 11, 2017; at which time all received sealed bids will be publicly opened and read. Any bid received after that date and time or which otherwise does not comply with this notice and the Bid Specifications and Documents will be deemed defective and will not be considered, and rejected.

The Village of Greenport is soliciting bids for one (1) or two (2) 4 x 4 pick-up trucks, per the specifications available on the official Village of Greenport website: www.villageofgreenport.org. (Bidder should submit proposal for either one truck or two trucks.)

A copy of the Bid Specifications and Documents may be obtained at the Greenport Village Hall on or after Thursday, August 31, 2017 from 9:00 a.m. to 4:00 p.m. Monday through Friday, on regular Village business days or by visiting www.villageofgreenport.org. Bids must be submitted to the Village Clerk in a sealed envelope only plainly marked on the outside with the description:

Bids must be filed in accordance with the specifications of the Village of Greenport and New York State General Municipal Law Section 103. The Bid Price shall exclude any federal, state or local taxes; from which the Village of Greenport is exempt. The Village of Greenport reserves the right to reject any and all bids.
