2	name is Jane Ratsey-Williams and I would like to
3	welcome you to the March 2023 meeting of the
4	Historic Preservation Commission at the Third Stree
5	Firehouse.
6	Will the Board members please introduce
7	themselves.
8	MEMBER BORRELLI: Roselle Borrelli.
9	MEMBER DAVIDSON: Barbara Davidson.
10	CHAIR RATSEY-WILLIAMS: Thank you, we have a
11	quorum.
12	Agenda No. 1 is a motion to accept and
13	approve the Minutes of the February 2023 regular
14	meeting. Do I have a second?
15	MEMBER DAVIDSON: Yes.
16	CHAIR RATSEY-WILLIAMS: All those in favor?
17	(ALL AYES).
18	All those opposed?
19	(No Response).
20	Motion carried.
21	Item No. 2, motion to discuss scheduling a
22	worksession regarding the recent inclusion of Green
23	Hill Cemetery to the Historic District.
24	I'm going to table this for this evening as
25	we don't have all the information in as of yet to

- 1 proceed.
- 2 Item No. 3, 616 Main Street. Discussion and
- 3 possible motion on the application of Andrew
- 4 McCulloch. Applicant proposes to paint the home blue
- 5 (Behr "Atlantic") with a white trim (Behr "white")
- from its current yellow color.
- 7 This is SCTM No. 1001-3-4-4.
- 8 (Member McMahon has joined the Board).
- 9 CHAIR RATSEY-WILLIAMS: Is there someone here
- 10 to represent this property?
- MR. NOONE: No, there is not. If you recall,
- 12 I called you to discuss it. The candidate couldn't
- 13 be here tonight and said that that was okay. It's
- 14 fairly straightforward.
- 15 CHAIR RATSEY-WILLIAMS: Thank you. It is very
- 16 straightforward.
- This is an older house, I looked it up, in
- the 1970s and '80s there was a group here called the
- 19 Cultural Resource Center and they went house to
- 20 house, with permission, walked around the property
- 21 and sometimes even inside.
- This house is believed to have been built in
- the 1840s and it's showing up on an 1858 Chase map,
- 24 which is pretty interesting. It had some pretty
- 25 nasty awnings made out of plastic, I believe, and,

- in the 1970's. And the house now is looking very
- 2 nice, and I think the color is beautiful. Are there
- 3 any comments?
- 4 MEMBER BORRELLI: I think the colors are
- 5 great.
- 6 CHAIR RATSEY-WILLIAMS: Barbara?
- 7 MEMBER DAVIDSON: Yup.
- 8 CHAIR RATSEY-WILLIAMS: Dennis, welcome.
- 9 MEMBER MCMAHON: I'm not on page here.
- 10 CHAIR RATSEY WILLIAMS: Okay.
- 11 MEMBER DAVIDSON: 616 Main Street.
- 12 CHAIR RATSEY-WILLIAMS: Excuse me, if there
- are no more comments, I would like to --
- MEMBER MCMAHON: (Perusing). Oh, yes, very
- 15 nice.
- MEMBER DAVIDSON: Paint it blew and white.
- 17 MEMBER MCMAHON: Yes, beautiful.
- 18 CHAIR RATSEY-WILLIAMS: I would like to note
- our Commission is only voting on the work described
- 20 in your February 24th application. Any other changes
- or new projects you wish to make, you'll have to
- come back in front of the HPC again.
- I make a motion to approve this application
- and issue a certificate of appropriateness, as the
- application is in keeping with the criteria in

Greenport Village Code 76-7. 1 2 Is there a second? 3 MEMBER BORRELLI: I'll second. 4 CHAIR RATSEY-WILLIAMS: Thank you. All those 5 in favor? (ALL AYES). 6 7 All opposed? 8 (No response). 9 Motion carried. Thank you. 10 Village Hall will contact you when the 11 certificate of appropriateness is ready. 12 Thank you, Michael. Item No. 4, 148 Bay Avenue. Discussion and 13 14 possible motion on the application of Nicholas 15 Mazzaferro on behalf of Chris and Lauren Issacs. 16 The applicant proposes to replace existing windows with new Andersen 400 series "2 over 2" 17 18 windows. Applicant also proposes an off-street 19 parking space accessed by a new driveway and curb 2.0 cut. The applicant has received a proper variance 21 for the driveway. This is SCTM No. 1001-5-2-15. 22 23 Is there someone here representing them? 24 Would you kindly step to the podium and give

your name and address for the record. Thank you.

- 1 MR. ISSACS: My name is Christopher Issacs,
- 2 I'm the owner of 148 Bay Avenue. We own that
- 3 property. We also live in the city, 318 East 19th
- 4 Street, New York, New York.
- 5 CHAIR RATSEY-WILLIAMS: Thank you.
- 6 Mr. Mazzaferro came before us at the last
- 7 meeting.
- 8 MR. ISSACS: Yes. He's in Nevada right now, I
- 9 think skiing.
- 10 CHAIR RATSEY-WILLIAMS: And Dennis, you
- 11 discussed the windows with him, on this house, with
- 12 Mr. Mazzaferro at the last meeting?
- MEMBER MCMAHON: We have. I believe so. Yes.
- MR. ISSACS: That's my understanding as well.
- 15 CHAIR RATSEY-WILLIAMS: And the curb cuts,
- does anyone have any questions about this?
- 17 MEMBER BORRELLI: You are here just for the
- 18 windows then.
- 19 MR. ISAACS: The windows and the driveway,
- 20 yes.
- 21 MEMBER BORRELLI: I just had a quick question.
- I don't see it listed or anything, but were there
- plans to change the front door?
- MR. ISAACS: There are no plans to change the
- front door other than to renovate it, which is to

- 1 say it's really -- it wouldn't require approval, I
- 2 assume. We're just going to make it -- it's got
- 3 splinters, for our kids, so we are going to fix it.
- 4 But we are not going to replace it. It's a beautiful
- 5 door, so, no.
- 6 MEMBER BORRELLI: That's what I thought.
- 7 CHAIR RATSEY-WILLIAMS: Are there any other
- 8 questions?
- 9 (No response).
- 10 I think Mr. Mazzaferro coming before us was,
- 11 made things very clear. So, thank you.
- MR. ISAACS: Okay. You're very welcome.
- 13 CHAIR RATSEY-WILLIAMS: I would like to note
- our Commission is only voting on the work described
- in your January 3rd, 2023 application.
- Any other changes or new projects that you
- wish to make, you'll have to come back before the
- 18 Board. I hope that is clear.
- 19 I make a motion to approve this application
- 20 and issue a certificate of appropriateness as the
- 21 application is in keeping with the criteria in
- 22 Greenport Village Code 76-7.
- Is there a second.
- MEMBER DAVIDSON: Second.
- 25 CHAIR RATSEY-WILLIAMS: All those in favor?

- 1 (ALL AYES).
- 2 CHAIR RATSEY-WILLIAMS: All opposed.
- 3 (No response).
- 4 None opposed. Motion carried. Thank you.
- 5 Village Hall will contact you when the --
- 6 MR. ISAACS: I have a question. Sorry,
- 7 didn't mean to interrupt you.
- 8 CHAIR RATSEY-WILLIAMS: That's fine.
- 9 MR. ISAACS: Where will they send the
- 10 certificate of appropriateness?
- 11 CHAIR RATSEY-WILLIAMS: Well, you can speak
- 12 with Mike Noone here.
- MR. NOONE: Within the next couple of days
- 14 I'll make out a certificate of appropriateness, Jane
- will come to Village Hall and sign it and I'll
- 16 contact you, and then when you are free, you said
- 17 you live in the city as well.
- MR. ISAACS: We do. Or he can pick it up,
- 19 too. He'll be back in town in about a week.
- 20 MR. NOONE: It will be ready within the next
- couple of days to be picked up. I'll let you know
- when.
- MR. ISAACS: Okay, thank you.
- 24 MEMBER BORRELLI: Jane was kind enough to pull
- 25 the building structure inventory forms that we have,

- that were done in a study in the '70's, and I was
- 2 just looking at it to see what they say.
- 3 The porch was added afterwards. There is a
- 4 new roof, rear additions, without any date, but
- 5 after 1897. But the interesting things are usually
- 6 in the back. It says very late Victorian home with
- 7 little detail but for a mansard roof, in a dense
- 8 section of Bay Avenue, converted from a smaller
- 9 house after 1897. Street leads to the harbor.
- 10 Mansard roof has beveled glass front door, standard
- interior fence-like porch enclosure and the site of
- 12 an earlier Dering house, would have been the last
- name.
- 14 So date of initial construction is between
- 15 1890 and 1897.
- MR. ISAACS: It's a little younger than we
- 17 thought. We had thought about 1885, so, yes. Very
- 18 interesting. Thank you.
- 19 CHAIR RATSEY-WILLIAMS: You are welcome to the
- 20 sheet.
- MR. ISAACS: Where is that, I was going to
- say. You don't have to give it to me right now.
- 23 CHAIR RATSEY-WILLIAMS: No, no. You are
- 24 welcome to come get it.
- MR. ISAACS: Okay, thank you.

1	CHAIR RATSEY-WILLIAMS: These sheets are also
2	at Village Hall, at the Cultural Resource.
3	Item No. 5, 422 Second Street. Discussion and
4	possible motion on the application of Walker and
5	Alexandra Hawkins. Applicants propose installing a
6	natural wood-colored cedar fencing on the north side
7	of the property. The proposed fence would match
8	existing fencing on the east and south sides of the
9	property. This is SCTM No. 1001-4-2-35.2.
10	Are Alexander or Walker here?
11	Would you please step up to the podium and
12	give your name and address, please, for the record.
13	MS. HAWKINS: Alexandra Hawkins, 422 Second
14	Street.
15	CHAIR RATSEY-WILLIAMS: Thank you. You said
16	cedar-colored fencing. Is it not cedar fencing? Or
17	is it just cedar colored?
18	MS. HAWKINS: Um, I believe the fence is
19	cedar, so it is going to be weathered like the
20	other it will weather like the other.
21	CHAIR RATSEY-WILLIAMS: You'll keep it
22	natural.
23	MS. HAWKINS: Yes, keep it natural.
24	CHAIR RATSEY-WILLIAMS: Because the fence
25	across the front is painted, correct?

1	MS. HAWKINS: Yes, the fence across the front
2	is painted green, but this would be a natural fence
3	to match the back and south side of the property.
4	CHAIR RATSEY-WILLIAMS: Okay. Thank you. Are
5	there any questions?
6	(Negative response).
7	MEMBER MCMAHON: Nope. Pretty straightforward.
8	CHAIR RATSEY-WILLIAMS: Janice Claudio who is
9	a member of the Board but couldn't meet us, looked
10	at the plans, and although it's not under our
11	jurisdiction, she would have liked to have
12	mentioned, had she been here, she asked me to, that
13	the fence that is running along the driveway, that's
14	the new one, correct?
15	MS. HAWKINS: The fence running along the
16	driveway, so it's not
17	CHAIR RATSEY-WILLIAMS: Is the south one.
18	MS. HAWKINS: Is the south fence, yes. There
19	is actually two fences. One belongs to one neighbor
20	and one a second neighbor. So they are kind of like
21	two different fences. They look similar but the top
22	is different, yes.
23	CHAIR RATSEY-WILLIAMS: Okay. Her concern, and
24	as I said, it's not under our jurisdiction, is that
25	the fence, too often a fence will go right up to the

- 1 sidewalk, and when a car is backing out, it is
- 2 virtually impossible to see someone walking down the
- 3 sidewalk.
- 4 So if the fence could be set back a little
- 5 bit, it would be a sort of a safety precaution and
- 6 something for you to consider.
- 7 MEMBER MCMAHON: Is this a side yard fence?
- 8 MS. HAWKINS: It's a side yard fence, so it's
- 9 the opposite side of my driveway. And there is --
- 10 MEMBER MCMAHON: Is six foot allowed on the
- 11 side yard?
- MS. HAWKINS: No, it will be four feet and
- 13 then transition to six feet.
- 14 MEMBER MCMAHON: That's good. That's great.
- 15 Four feet, that's usually not an issue, but, yes, if
- 16 you can pull it back a foot or so from the sidewalk.
- 17 CHAIR RATSEY-WILLIAMS: I mean, you drive a
- 18 truck, so four feet is good. If you are in a
- smaller car, it's not always simple. It's just
- 20 something to consider.
- 21 Are there any other comments or questions.
- (Negative response).
- Okay.
- MEMBER MCMAHON: No, we're good.
- 25 CHAIR RATSEY-WILLIAMS: Okay, I would like to

- 1 note our Commission is only voting on the work
- described on your January 3rd, 2023 application.
- 3 Any other changes or new projects that you wish to
- 4 make, you'll have to come back in front of the HPC
- 5 again. Is that clear?
- 6 MS. HAWKINS: Uh, huh.
- 7 CHAIR RATSEY-WILLIAMS: Thank you. I make a
- 8 motion to approve the application and issue a
- 9 certificate of appropriateness as the application is
- in keeping with the criteria in Greenport Village
- 11 Code 76-7.
- 12 Is there a second?
- 13 MEMBER BORRELLI: I'll second.
- 14 CHAIR RATSEY-WILLIAMS: All those in favor?
- 15 (ALL AYES).
- 16 All those opposed?
- 17 (No response).
- 18 Motion carried. Thank you. Village Hall
- 19 will contact you when your certificate is ready.
- MS. HAWKINS: Thank you.
- 21 CHAIR RATSEY-WILLIAMS: As that is a newer
- 22 building, we do not have the cultural resource --
- MS. HAWKINS: Oh, I know.
- 24 CHAIR RATSEY-WILLIAMS: As that is not an
- 25 historic building. Just for the record.

Okay, Item No. 6 - 455 Main Street. 1 2 Discussion and possible motion on the 3 application of Deborah Schade. Applicant proposes to remove and replace an existing trellis, an 4 5 existing fence, cracked path, patio and steps, on the south side of the property. 6 7 This is SCTM No. 1001-4-7-19. 8 Is there anyone here to address that? 9 Thank you, would you step up to the podium 10 and give your name and address, please. 11 MS. WILCENSKI: Hi, I'm Catherine Wilcenski 12 and I'm here for 455 Main Street. 13 CHAIR RATSEY-WILLIAMS: Thank you. Do you 14 want to give us, you have given us very detailed, beautiful plans. Is there anything special you 15 would like to share with us? 16 MS. WILCENSKI: Um, hopefully that concludes 17 most of what you need there. 18 19 Currently, as you can see in the proposal, 20 the existing sidewalk and path is kind of cracked, a 21 little bit hazardous, it's very narrow. The trellis 22 is fairly unusable. The door doesn't really work 23 and it's a bit crooked, and there is also a bit of a 24 drainage problem there.

So we are proposing to make the entrance to

25

- 1 the garden more central; improve the patio, to
- 2 expand the existing brick way there.
- 3 MR. NOONE: The applicant dropped off samples
- 4 of the brick path.
- 5 MS. WILCENSKI: Yes. So that's for the brick.
- I have a sample for the stone for the steps as well.
- 7 CHAIR RATSEY-WILLIAMS: Thank you, Mike.
- 8 MR. NOONE: Do you want to --
- 9 CHAIR RATSEY-WILLIAMS: That was one of my
- 10 questions. So across the front, I think it says a
- 11 herring bone pattern, correct? On the existing now.
- MS. WILCENSKI: Yes.
- 13 CHAIR RATSEY-WILLIAMS: Is this the new
- pattern for the entire front?
- MS. WILCENSKI: That is not the pattern, it's
- just the brick type. So it will match the existing
- 17 pattern.
- 18 CHAIR RATSEY-WILLIAMS: Okay. And what stone
- are the, on the curb step, correct.
- 20 MS. WILCENSKI: South Bay Quartzite.
- 21 MEMBER MCMAHON: This is certainly thorough.
- 22 CHAIR RATSEY-WILLIAMS: Yes, very thorough.
- 23 Right down to the plant material, so.
- MEMBER MCMAHON: That's beautiful.
- 25 MEMBER BORRELLI: It's really lovelily.

- 1 CHAIR RATSEY-WILLIAMS: It is lovely. I love
 2 all the greenery going into the Village. That's
 3 nice. He's always done a beautiful job anyway. But
 4 this makes it even more special.
- 5 MS. WILCENSKI: Thank you.
- MEMBER BORRELLI: I think the entrance, like
 the rounded stairs, the archway and centering it
 sort of in between the two houses like that, is
 going be to be a huge improvement. It's really
 nice. Beautifully done.
- MS. WILCENSKI: Thank you.
- 12 MEMBER DAVIDSON: Yup, very nice.
- 13 CHAIR RATSEY-WILLIAMS: Are you the other
- solstice garden?
- MS. WILCENSKI: Yes.
- 16 CHAIR RATSEY-WILLIAMS: I read about that, so.
- MS. WILCENSKI: Great.
- 18 CHAIR RATSEY-WILLIAMS: Are there any
- 19 questions?
- 20 MEMBER MCMAHON: No. Beautiful. I want one.
- MEMBER DAVIDSON: No, I'm good.
- 22 CHAIR RATSEY-WILLIAMS: I would like to note
- our Commission is only voting on the work described
- in your 2023 application. Any other changes or new
- 25 projects that you wish to make, you'll have to come

- 1 back in front of the Board. Is that clear?
- 2 MS. WILCENSKI: Yes.
- 3 CHAIR RATSEY-WILLIAMS: Thank you. I make a
- 4 motion to approve this application and issue a
- 5 certificate of appropriateness as the application is
- 6 in keeping with the criteria in Greenport Village
- 7 Code 76-7. Is there a second?
- 8 MEMBER DAVIDSON: Second.
- 9 CHAIR RATSEY-WILLIAMS: All those in favor?
- 10 (ALL AYES).
- 11 All opposed?
- 12 (No response).
- Motion carried.
- 14 The Village will contact you when the
- 15 certificate is ready.
