## **Lucharitos Operating Report**

2. Lucharitos, located at 119 Main St, Greenport, NY 11944 operates with a maximum occupancy of seventy one persons, including staff and consumers. This location is in a commercial area surrounded by other businesses with no concerns of violating sound ordinances of the residential areas in Greenport Village.

It is intended for the business to conduct numerous events throughout the summer season with the expectancy that such events will pause as the fall season begins. During these events it is anticipated that seating will be removed from the business to create an open space which will be used as a dance floor. Security arrangements will include a rotation of privately hired individuals who have been vetted by the business and trusted to maintain order. Management will be present at all times overseeing events in this location to maintain the safety and control within the building. It is expected these events will begin May 3rd.

- 3. Lucharitos is open 7 days a week from 11am-10pm most days of the Summer season.

  Special events are expected to occur on the evenings of Friday and Saturday. These events may include music provided by a DJ or Karaoke company, typically falling outside of our regular operating hours. Beginning at approximately 10pm and ending at 2am. There may be extra events held on weekdays. These events may require the business to be closed to the public and are expected to align with our regular operating hours.

- 5. No person responsible for the business has been convicted of any criminal offenses in the last 5 years.
