RESOLUTIONS

RESOLUTION # 04-2024-1

WHEREAS, the New York State Environmental Conservation Law and the regulations of the Department of Environmental Conservation as contained in 6 NYCRR Part 617 require review of the possible environmental consequences of various actions under consideration by the Board of Trustees, and

WHEREAS, the Board of Trustees is considering the adoption of Bill 4 of 2023, a proposed local law amending Chapter 132 of the Code of the Village of Greenport, to establish a paid parking program and paid parking facilities and zones in the Village; and

WHEREAS, the Board of Trustees has considered the nature and impact of the proposed action; and

WHEREAS, the Board of Trustees has reviewed a Short Environmental Assessment Form prepared with respect to the proposed law,

NOW, THEREFORE, IT IS

RESOLVED, that the Board hereby finds and concludes that the Board of Trustees is the Lead Agency with respect to environmental impact review of proposed bill 4 of 2024 (to be adopted as Local Law 2 of 2024) as defined in the State Environmental Quality Review Act and its regulations (SEQRA), and

- A. the proposed adoption of Bill 4 of 2024 is an Unlisted Action under SEQRA;
- B. the Board has considered the adoption of Bill 4 of 2024, which law provides for the creation of a paid parking program and regulations applicable to the program;
- C. the Board has thoroughly reviewed the Short Environmental Assessment Form and the supplemental description of the proposed action;
- D. the Board also has considered the following factors and made the following conclusions in respect to its review of the environmental impacts of the proposed action:
 - the proposed action would not result in any substantial adverse change in existing air quality, ground or surface water quality or quantity, traffic or noise levels, nor any

- substantial increase in solid waste production, nor create a substantial increase in the potential for crosion, flooding, leaching or drainage problems;
- ii. the proposed action would not result in the removal or destruction of large quantities of vegetation or fauna, substantial interference with the movement of any resident or migratory fish or wildlife species, impacts on a significant habitat area, substantial adverse impacts on a threatened or endangered species of animal or plant, or the habitat of such a species, or other significant adverse impacts to natural resources;
- iii. the proposed action would not impair the environmental characteristics of any Critical Environmental Area;
- iv. the proposed action would not conflict with the community's current plans or goals as official approved or adopted;
- the proposed action would not impair the character or quality of important historical, archeological, architectural or aesthetic resources or of existing community or neighborhood character;
- vi. the proposed action would not result in a major change in the use of either the quantity or type of energy;
- vii. the proposed action would not create a hazard to human health;
- viii. the proposed action would not create a substantial change in the use, or intensity of use, of land, including agricultural, open space or recreational resources, or in its capacity to support existing uses;
- ix. the proposed action would not encourage or attract large numbers of persons to any place for more than a few days, compared to the number who would come to such

- place without such action;
- x. the proposed action would not create changes in two or more elements of the environment, no one of which would have a significant impact on the environment, but when taken considered together would result in a substantial adverse impact on the environment;
- xi. the proposed action would not create substantial adverse impacts when considered cumulatively with any other actions, proposed or in process;
- xii. the proposed action would not result in substantial adverse impact with respect to any relevant environmental consideration, including noise, aesthetics, traffic, air quality, water quality or adequacy of water supply, drainage, soil conditions, or quality of life in the community in general and the immediate neighborhood in particular;
- xiii. the proposed action would enhance the protection of the environment in the Village, in that it would preserve and maintain the existing character of the Village;
- E. the proposed action would not have a significant adverse environmental impact;
- F. no further environmental review is required with respect to the proposed action, and
- G. the Mayor, or his designee, is authorized to execute the Short EAF in a manner consistent with the foregoing findings concluding that the proposed action will not result in a significant adverse environmental impact.

RESOLUTION # 04-2024-2

Paid Parking Enabling Law Adoption Resolution

WHEREAS, the Board of Trustees has been considering the adoption of a local law that provides for a paid parking program (Bill VOG04-2024), and

WHEREAS, the parking program enables the Board to establish paid parking lots and spaces in the Village, and

WHEREAS, the law is not a zoning law subject to referral to the Suffolk County Planning Commission, and

WHEREAS, the Board has determined that the proposed law is an Unlisted action under the State Environmental Quality Review Act and will not result in a significant adverse environmental impact, and

WHEREAS, the Board published and posted legal notice of a scheduled public hearing on the proposed law, and

WHEREAS, the Board held a public hearing on the proposed local law, and

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of the Village of Greenport hereby adopts the proposed law (VOG 04-24) as Local Law 2 of 2024, a local law amending Chapter 132 of the Code of the Village of Greenport, to establish a paid parking program and paid parking facilities and zones in the Village, and

BE IT FURTHER RESOLVED, that the Board directs the Village Clerk to file the law with the New York Secretary of State.

At the Village of Greenport Board of Trustees Regular Meeting held on Thursday, March 28, 2024; the Board adopted a

RESOLUTION amending RESOLUTION 10-2023-8 approving amended Supplemental Agreement Number 1 between the Village of the Greenport and the New York Department of Transportation and Authorizing Mayor Stuessi to sign Supplemental Agreement Number 1.

WHEREAS, a Project for the Village of Greenport to reconstruct existing North Ferry Terminal, P.I.N. 0761.79 (the Project") is eligible for funding under Title 23 U.S. Code, as amended, that calls for the apportionment of the costs such program to be borne at the ratio of 80% Federal funds and 20% non-federal funds; and

WHEREAS, the Village of Greenport desires to advance the Project by making a commitment of 100% of the non-federal share of the costs of \$686,584.

NOW, THEREFORE, the Board of Trustees of the Village of Greenport, duly convened does hereby

RESOLVE, that the Board of Trustees of the Village of Greenport hereby approves the above-subject project; and it is hereby further

RESOLVED, that the Board of Trustees of the Village of Greenport hereby authorizes the Treasurer of the Village of Greenport to pay in the first instance 100% of the federal and non-federal share of the construction cost of \$2,682,917.00 work for the Project or portions thereof; and it is further

RESOLVED, that the sum of \$2,682,917.00 is hereby appropriated pursuant to a Bond Resolution and made available to cover the cost of participation in the above phase of the Project; and it is further

RESOLVED, that in the event the full federal and non-federal share costs of the project exceeds the amount appropriated above, the Board of Trustees of the Village of Greenport shall convene as soon as possible to appropriate said excess amount immediately upon the notification by the Village Administrator thereof, and it is further

RESOLVED, that the Mayor of the Village of Greenport be and is hereby authorized to execute Supplemental Agreement No. 1

RESOLVED, that the Village Administrator of the Village of Greenport be and is hereby authorized to execute all necessary Agreements, certifications or reimbursement requests for Federal Aid and/or Marchiselli Aid on behalf of the Village of Greenport with the



New York State Department of Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the municipality's first instance funding of project costs and permanent funding of the local share of federal-aid and state-aid eligible Project costs and all Project costs within appropriations therefore that are not so eligible, and it is further

RESOLVED, that a certified copy of this resolution be filed with the New York State Commissioner of Transportation by attaching it to any necessary Agreement in connection with the Project. and it is further

RESOLVED, this Resolution shall take effect immediately

Bill VOG 04-24.

A local law amending Chapter 132 of the Code of the Village of Greenport, to establish a paid parking program and paid parking facilities and zones in the Village.

Section 1. Chapter 132 of the Code of the Village of Greenport is hereby amended by adding Article X, to read as follows:

"Article X. Paid Parking Program.

§132-60. Establishment of Paid Parking Program.

The Village Board of Trustees hereby establishes a paid parking plan in areas as authorized by this Article and as determined by the Board of Trustees by resolution from time to time. The Village Clerk, upon the approval by resolution of the Board of Trustees, may procure software programs, if needed, and other equipment and services that are determined necessary to implement the paid parking plan.

§132-61. Establishment of Paid Parking Zones.

Paid parking zones are hereby designated as being those parts of streets or public parking fields upon which paid parking is now designated or may hereafter be designated from time to time by resolution of the Board of Trustees.

§132-62. Applicability.

- A. Hours and days of operation. The provisions of this Article shall apply to all Village paid parking zones during such hours as shall be posted for their application.
- B. Authority to establish and vary hours and days. The Board of Trustees may establish and vary, by resolution adopted from time to time, the hours and days during which this Article shall be effective. Hours of operation shall be displayed within the paid parking zones.

§132-63. Paid Parking Zone Charges.

Parking fees shall be determined from time to time by resolution adopted of the Board of Trustees. Such fees shall be documented within any smartphone application or other equipment employed by the Village pursuant to this Article.

§132-64. Paid Parking Zone Equipment and Pay Facilities.

Except in a period of emergency determined by an officer of the Fire or Police Department, or in compliance with the directions of a police officer or traffic control sign or signal, when any vehicle shall be parked in any parking space within a paid parking zone pursuant to this Article, the operator of such vehicle shall, upon entering the parking space, immediately register with the paid parking smartphone application and make payment for parking in accordance with the applicable fees. Alternatively, the operator of such vehicle may register by calling a toll-free number by personal or public telephone and arranging for payment by phone. The owner and/or operator of a vehicle shall be responsible for the cost of any surcharges imposed by any credit card company in connection with the payment for parking, as indicated specifically on the smartphone application or on the telephone application.

§132-65. Payment Procedure.

Failure to make proper payment in accordance with the instructions on the smartphone application or the phone alternative for the amount of time that the vehicle will be parked in the parking stall shall constitute a violation of this Article.

§132-66. Failure to Pay.

If a vehicle shall remain parked in any a parking space beyond the parking time limit set for such vehicle's parking space, and if the paid parking information system shall indicate such illegal parking, such vehicle shall be considered as parking overtime and beyond the period of legal parking time, and such parking shall be a violation of this Article.

§132-67. Exemptions.

In the paid parking areas designated by the Board of Trustees, all spaces designated for handicapped parking and spaces designated for limited (thirty-minute or less) parking shall be exempt from the provisions of this Article.

§132-68. Assignment of Fees Collected/Records.

The payments required hereunder are hereby levied and assessed as fees to be deposited within the general fund for the Village. It shall be the duty of the Village Treasurer to keep a record of the collection of fees from parking and to deposit said fees in the appropriate municipal account.

§132-69. Violations.

It shall be unlawful and a violation of the provisions of this Article for any person to cause, allow, permit or suffer any vehicle registered in the name of or operated by such person to be parked without payment within a paid parking space or beyond the period of legal parking time established for any paid parking zone as herein described. Any violation of any provision of this Article shall be subject to a penalty of \$50 per offense.

Section 3. Severability. If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 4. Effective date. This local law shall take effect immediately upon filing with the Secretary of State.

Wednesday, March 20, 2024

OPENING

Chief Wayde Manwaring opened the meeting at 7:00pm with the Pledge of Allegiance to the Flag and a moment of silence for the departed members.

THOSE WISHING TO ADDRESS THE BOARD

- Robert Corwin reported that Dennis Kenter is working on a new control board for the siren. He suggested that we go back to blowing the siren twice for EMS calls. Once for 6 o'clock, once for funeral, rescue calls twice, and fire several. We had a funeral siren go off and a member didn't have his radio on so they showed up thinking it was a call.
- 2. Robert Corwin also reported that North Fork Fire Police is requesting to have their dinner at Station 1.

READING OF THE PREVIOUS MINUTES

Motion made by C. Harris, seconded by A. Volinski III, to approve the minutes of the February 21, 2024 meeting of the Board of Wardens as printed and distributed. Motion carried.

FINANCE COMMITTEE

The finance committee report was read by Chief Manwaring. Motion made by P. Harris, seconded by C. Harris, to accept the report. Motion carried.

W. Miller mentioned that the AED on 15 is no good, it needs to be replaced. The 500s are obsolete. N. Corwin said that she didn't know that 15 had one-could have gotten a rebate, but it's too late now. W. Miller mentioned that all trucks are supposed to have an AED. We need 2 AEDs—one for 8-3-4 and one for 8-3-15. N. Corwin said it would be a good idea to stick a star of life on whichever cabinet it's going in so everyone knows where it is. B. Purcell mentioned that there is one on 8-3-1 but he has no idea how old it is or if it works.

Buildings and Grounds

- C. Harris reported that he met with D. Nyce and he is going to build a
 cabinet in the space to the right of the roll up. He has to speak with the
 electrician about moving the contactor for the fryer so we can put stuff
 against the wall.
- 2. Peter Harris said that he noticed that the parking lot at Station 1 has a lot of severe cracking. He measured it and it is over 1,300 feet of cracking. He contacted North Fork Sealcoating to get a quote. The quote is for blowing out and filling of the cracks, \$1,750. If we don't do something it's going to start falling apart. Seal the cracks for now and then maybe next step would be to seal the whole thing at some point. Motion made by C. Harris, seconded by J. Walters, to move forward with fixing the parking lot cracks. Motion carried.
- 3. C. Harris reported that they took the element out of the radiator. New one should be in Friday or early next week. The boiler relief valve in the basement needs to be replaced too.
- C. Harris also said that in the bathroom where the hand dryers are, water drips down. He is going to add a sheet of stainless steel so it doesn't damage the wall/paint.
- 5. S. Hollid asked who is covering the cost of the cabinet that doesn't fit if the company is the one that made the error. C. Harris said that we are going to use the cabinet somewhere else and we are going to have to

cover the cost of the new one being built. S. Hollid said no one takes accountability for their mistakes.

Corwin said there is a guy in Orient that does the gym equipment. It was also brought up to try Mills, but she doesn't know if they do pleather. N. Corwin will get a quote.
- 7. Fire Police- Requesting permission to have dinner at Station 1.
- 8. Water Rescue- Fire pump set up. 2nd Asst. Chief Johnson said he spoke with W. Jensen and the company changed one of the pumps because it had aluminum inside of it, they went with something bigger. They should get back to him at the end of the week with cost etc. He will bring back the info.

UNFINISHED BUSINESS

C. Harris said that in regard to the firetruck outside, a representative from the county came out at the end of February and looked at the truck. It was at that time that we found out that FRES was going to wrap it and use it as a PR thing and blocking vehicle for marathons and stuff. C. Harris is not happy that they didn't let us know that they were changing the use of it. The next week he got a call from the Terry Farrell Fund and they apologized that it was still there and he was also unhappy that they were doing something different with it. They will take the truck

and find someone that can use it. Motion made by W. Miller, seconded by A. Volinski III, to re-donate the truck back to the Terry Farrell fund. Motion Carried.

NEW BUSINESS No Report.

GOOD OF THE DEPARTMENT

- 1. Peter Harris said that much to his dismay, he saw pictures of the new renderings of the skate park. If this plan goes through, we are going to lose another big chunk of open area. GFD has been holding fundraisers there for a long time. It was also mentioned putting the ice-skating rink there too. The ice-skating rink being at Mitchell Park benefits the restaurants and shops. The Wardens haven't heard anything from Mary Bess Phillips as our liaison about the skate park. Mary Bess Phillips said that it is not Village approved and it is just a dream that the group has. The Village understands that we need to protect space for the fire department. If it came to the Village, she would have mentioned it. It is just in the talking stages. They raised all the money on their own, they haven't received any money from the Village. Also, the Village is pushing to have the ice-skating rink back at Mitchells Park. Much more discussion ensued about parkland/open space.
- 2. Peter Harris also mentioned that this weekend in the span of 3 minutes there were 2 EMS calls for alcohol overdoses. We bring them to ELIH and just let them sleep it off and provide them with something to eat. It is ridiculous. When the police officers see them intoxicated and not sick, they need to be arrested and not just given a place to sleep it off. Something needs to change for EMS. There is no drinking allowed in public, but the police look the other way.
- A. Volinski III wanted to mention that the May Mile is scheduled for May 11, 2024.
- Motion made by A. Volinski III, seconded by N. Corwin, to allow the Boy Scouts to use the firehouse for their pancake breakfast. Motion Carried.
- 5. A. Volinski III also mentioned that the sign still has Washington's birthday on it. Chief Manwaring said that 1st Asst. Chief de Kerillis knows how to operate it now. A. Volinski III said that more people need to learn as well. He also mentioned that the time is running on top of the message.

- 6. A. Volinski brought up that Eagle Hose needs radios and Relief Hose needs radios. He asked where the money from the \$50,000 grant went. Chief Manwaring said that the air bottles were purchased. A. Volinski asked if all the money was spent on bottles. Chief Manwaring said that it was approved at this meeting. It was changed to 24 bottles and to use the rest of the money towards the boat. W. Miller said that there was some confusion about the way that it was presented. He thought that it was an emergency and we were going to be without bottles, not that it was a bonus thing. C. Harris said that when he first joined this board, he suggested a tracking data base so that we wouldn't have this issue. Chief Manwaring said next budget we will do radios. A. Volinski III said that he has been asking for a copy of the budget at the Warden's meeting, so we know where we stand.
- W. Miller mentioned that his company has concerns about 8-3-5 being the back up if one of them isn't there to drive it. C. Harris said that there is going to be driver training in April.
- 8. A. Volinski III said that we need to schedule RIT training. W. Miller mentioned that we can't respond to a 24 in a personal vehicle. Chief Manwaring said that the officer of the truck can if they miss their truck. S. Hollid also said that they should respond to Station 2 if they want to go, not be picked up at Station 1. A. Volinski said that there were firefighters with gear in the back of the ambulance and that shouldn't be the case. N. Corwin said that she didn't know she was going to bring her gear along, it won't happen again. W. Miller asked if we have a list of RIT certified members from the county. Chief Manwaring said that our SOP only says you need to be an interior firefighter, it needs to be changed.
- 9. Chief Manwaring reported that April 2 pump testing will be done on all trucks. N. Corwin asked if we have cleared the houseman to drive trucks. Chief Manwaring said no, it is not in his job description to move any trucks. He can drive the van and pick-up. There are plenty of officers that can shuffle trucks around if needed. P. Harris said that he is doing a good job.
- 10.A. Volinski asked about ladder testing, they've had a ladder off for two years that needs to be repaired. Chief Manwaring said not yet.
- 11. B. Purcell said that it used to be that every truck has bottles and kept them with the truck. We should go back to the old way and keep the same bottles, so we know what's what. A. Volinski said he thinks it's a

- good idea that we look into the tracking system. C. Harris said that he will look next budget.
- 12.P. Harris asked how the new secretary has been doing since the last meeting. Chief Manwaring said she is doing much better and will be on her own in mid-April.
- 13.8-3-5 requests that upon Rescues move to the back they would like to have that space. N. Corwin said that is already being traded off to old 33 and the houseman since we are taking their space. W. Miller said that the box doesn't even belong to the FD. P. Harris stated we are a company and they are a unit and there would be enough room in our current locker for them to put their stuff. N. Corwin said whatever makes the most sense to reallocate the space is fine.
- 14. W. Miller asked what we are doing with the Stonybrook vehicles and are we abandoning the idea of the addition to the building. N. Corwin said they aren't abandoning the idea. We will relocate now and if we eventually do the addition and need to relocate, we can, everything will be on wheels.

READING OF THE MINUTES

Motion by Joseph Walters, seconded by Peter Harris, to dispense with the reading of the minutes of tonight's meeting. Motion carried.

ADJOURMENT

Motion by Joseph Walters, seconded by Peter Harris, to adjourn. Motion carried. The meeting was adjourned at 8:45pm.

A RESOLUTION AUTHORIZING THE ISSUANCE OF \$700,000 BONDS OF THE VILLAGE OF GREENPORT, SUFFOLK COUNTY, NEW YORK, TO PAY THE COST OF IMPROVEMENTS TO SIDEWALKS AND CURBS, IN AND FOR SAID VILLAGE.

WHEREAS, all conditions precedent to the financing of the capital purposes hereinafter described, including compliance with the provisions of the State Environmental Quality Review Act to the extent required, have been performed; and

WHEREAS, it is now desired to authorize the financing of such capital project; NOW, THEREFORE, BE IT

RESOLVED, by the Board of Trustees of the Village of Greenport, Suffolk County, New York (the "Village"), as follows:

Section 1. For paying the cost of improvements to sidewalks and curbs, in and for the Village, including incidental expenses in connection therewith, a class of objects or purposes, there are hereby authorized to be issued \$700,000 bonds of said Village pursuant to the provisions of the Local Finance Law.

Section 2. The estimated maximum cost of the aforesaid class of objects or purposes is hereby determined to be \$700,000, and the plan for the financing thereof is by the issuance of \$700,000 bonds of said Village authorized to be issued pursuant to this bond resolution.

Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the bonds herein authorized, including renewals of such notes, is hereby delegated to the Village Treasurer, the chief fiscal officer or the Deputy Village Treasurer. Such notes shall be of such

terms, form and contents, and shall be sold in such manner, as may be prescribed by said Village Treasurer or Deputy Treasurer, consistent with the provisions of the Local Finance Law.

Section 5. The faith and credit of said Village of Greenport, Suffolk County, New York, are hereby irrevocably pledged for the payment of the principal of and interest on such obligations as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such bonds becoming due and payable in such year.

Section 6. Such bonds shall be in fully registered form and shall be signed in the name of the Village by the manual or facsimile signature of the Village Treasurer or Deputy Treasurer, as applicable, and a facsimile of its corporate seal shall be imprinted or impressed thereon and may be attested by the manual or facsimile signature of the Village Clerk.

Section 7. The powers and duties of advertising such bonds for sale, conducting the sale and awarding the bonds, are hereby delegated to the Village Treasurer or the Deputy Village Treasurer, who shall advertise such bonds for sale, conduct the sale, and award the bonds in such manner as Village Treasurer or Deputy Village Treasurer shall deem best for the interests of said Village; provided, however, that in the exercise of these delegated powers, the Village Treasurer or Deputy Village Treasurer shall comply fully with the provisions of the Local Finance Law and any order or rule of the State Comptroller applicable to the sale of municipal bonds. The receipt of the Village Treasurer or Deputy Village Treasurer shall be a full acquittance to the purchaser of such bonds, who shall not be obliged to see to the application of the purchase money.

SHIP VISITATION AGREEMENT

AGREEMENT dated _______, 2024 BETWEEN the VILLAGE OF GREENPORT ("Village"), 236 Third Street, Greenport, New York 11944, and Pride of Baltimore, Inc. ("Foundation"), 841 E. Fort Avenue, #342, Baltimore, MD 21230 (jointly with the Village the "Parties") regarding the Pride of Baltimore II ("Ship") for the stay by the SHIP at the Village of Greenport Marina as further detailed in this Agreement.

- 1. Ship shall arrive at the Village on July 18, 2024, and shall depart on July 22, 2024.
 - In lieu of payment for dockage, Pride of Baltimore II will open for FREE deck tours between the hours of 10:00am - 4:00pm.
 - b. The Foundation shall provide the following Ship schedule, subject to changes by mutual agreement of the Parties, in writing:

Thursday, July 18, 2024: arrive in Greenport at noon.

Thursday, July 18, 2024: FREE deck tours 2:00pm - 6:00pm.

Friday, July 19, 2024: FREE deck tours 10:00am - 4:00pm. Paid sail 5:00pm - 7:00pm.

Saturday, July 20, 2024: FREE deck tours 10:00am - 4:00pm. Paid sail 5:00pm - 7:00pm.

Sunday, July 21, 2024: FREE deck tours 10:00am - 4:00pm.

Monday, July 22, 2024: departure from Greenport 8:00am - 9:00am

- The Berth: Upon Ship's arrival in the Greenport Harbor, the Village shall provide berthing at the Village of Greenport Railroad Dock.
- 3. Public Visitation and Sailing: The Foundation will provide supervised on-board public sales, touring and visitation according to the schedule in this Agreement, weather permitting.
- 4. Foundation will provide and maintain Ship, properly crewed and equipped as required by marine authorities, in sound structural and operational condition, in the Greenport Harbor at a Berth to be designated by the Village.
- 5. Foundation shall name and provide contact information for a Ship. Representative to be the communication and contact person with the Village at all times during the Ship's stay in the Village, and if it is a different person, the name and contact information of the senior officer or representative of the Ship and Foundation while the Ship is at Greenport. The Village will name and provide contact information for Village representatives during the stay.
- For any private functions hosted on board Ship, the Foundation shall be responsible for cleanup and trash removal, ensure host liquor liability insurance coverage, and holds the Village harmless from loss or damage occasioned by its employees, agents, or guests.

- 7. The Village will provide during the stay:
 - a. normal waste trash removal, excluding hazardous or environmentally unsafe products for foreign and domestic garbage upon arrival and at regularly scheduled intervals throughout the stay provided that Ship staff shall be responsible for removing its waste from Ship and placing it in a designated container;
 - b. if available at the berth, access to 208-volt, 30 amp, 2 pole connection; and
 - c. potable water.
- 8. The Foundation acknowledges and agrees that the Ship Captain has complete and unfettered authority for the health and safety of the crew and safety of the Ship. Should he/she decide, in his/her professional opinion, that for any reason of safety to either the crew of the Ship and/or guests (including but not limited to bad weather) that the above mentioned dates and times cannot be complied with, or that a technical or mechanical problem (or a combination of any of the above) causes the inability to comply with the agreed upon dates and times, then the Foundation has a right to cancel all or part of the stay (or reschedule by mutual written agreement). Ship Captain and Foundation shall be responsible for and shall maintain the security and safety of the Ship and its crew.
- 9. The Ship must be registered, equipped, insured and maintained as may be required by law.
- 10. Foundation must have and maintain property (\$500,000), liability (\$1,000,000/\$2,000,000) and hull insurance (\$500,000) at all times during the stay, naming the Village of Greenport as additional insured, and provide proof thereof to the Village of Greenport.
- 11. The Village assumes no liability and shall not have any liability for the safety of the crew or The Ship or any fire, theft, vandalism, or damage.
- 12. The Foundation and the Ship agree to indemnify, hold harmless and defend the Village of Greenport and its officers and employees from any liability related to damage to the Ship or claims made against the Village of Greenport or its officers or employees relating to or arising from the stay or the activities of the Foundation or Ship. The Foundation and Ship agree to waive all rights of subrogation against the Village. The Village assumes no responsibility for damage or loss to the Ship or Ship personnel whether caused by severe storm, flood, fire, hail, frost, ice, lightning, tornado, wind, water, explosion, theft, malicious mischief, or other hazard or casualty. In the event of a severe storm or flood, the Foundation is solely responsible to take all emergency measures possible, the Village does not assume any responsibility for said protection and/or damage to the Ship.
- 13. No services such as mechanical, wood or fiberglass repair or replacement, canvas repair work may take place while the Ship is berthed at the marina.
- 14. The Village may designate marina quiet hours and other policies and rules.

- 15. Swimming, diving or fishing from the dock or Ship shall not be permitted at any time while the Ship is at the dock or marina. Children under twelve years of age that board the ship must wear a Coast Guard approved PFD while not berthed.
- 16. Any dispute arising from this Agreement shall be subject to the laws of the State of New York, and venue for any litigation shall be in a court of competent jurisdiction in Suffolk County, New York.
