1 (The Meeting was Called to Order at 7 p.m.)

2 MAYOR HUBBARD: All right. We'll call the  
3 meeting to order, it's 7 o'clock. Pledge to the  
4 Flag.

5 (All Stood for the Pledge of Allegiance)

6 MAYOR HUBBARD: Please remain standing for a  
7 moment of silence for Jorga A. Haasper, Deacon  
8 Frank Lyburt, Jr., and a longtime Village  
9 employee, Rosemarie Cagliuso.

10 (All Remained Standing for a Moment of Silence)

11 MAYOR HUBBARD: Thank you. Okay. Under  
12 announcements, Village Offices will be closed at  
13 noon on December 24th, 2021 and December 31st,  
14 2021.

15 The Village of Greenport Housing Authority  
16 is seeking a new Member.

17 I'm announcing tonight that Shawn Buchanan  
18 has been named to the Planning Board, my  
19 appointment for him. He's in the Greenport Fire  
20 Department. He's got a background in a lot of  
21 different social events and everything else. He  
22 was president of a condo association, so he knows  
23 about property management and things like that.  
24 He's the first person that had approached me and  
25 offered his services. So I know there's several

1 other people that have asked to be on the Planning  
2 Board or Zoning Board. When things come up, we  
3 will move through them and those people will be  
4 appointed accordingly when we need additional  
5 help. But I just want to thank Shawn Buchanan,  
6 and the Village Clerk will notify the Planning  
7 Board of his announcement and appointment to the  
8 Board. Okay.

9 Public hearings: A public hearing regarding  
10 the Wetlands Permit Application submitted by Wayne  
11 Turett to maintenance dredge, for the property at  
12 746 Main Street.

13 I'm sure you probably saw there was some  
14 recommendations from the CAC. This was dated  
15 December 22nd. The CAC has reviewed the above  
16 referenced application for a wetlands permit. The  
17 CAC recommends that the following three issues be  
18 addressed before final approval is granted for the  
19 permit:

20 The application states that there is a  
21 maintenance dredge project, and the CAC believe  
22 that this is not maintenance, as there is no  
23 indication that this has been dredged in the  
24 past. The application should be revised to  
25 reflect this.

1           Item 2: The application associated drawings  
2 say that the depth of dredging is 5 feet, and the  
3 New York State DEC permit states that dredging  
4 depth is 4 feet. The application drawings should  
5 be amended to reflect the New York State DEC  
6 permit.

7           The documentation is unclear as to the final  
8 disposition of the dredge spoils. There was a  
9 letter from the Town of Brookhaven that they will  
10 accept the spoils if they are tested and meet  
11 certain criteria. There's no indication that any  
12 testing was conducted, nor was any approval from  
13 the Town of Brookhaven.

14           Submitted from Paul Pallas, Village  
15 Administrator, from the CAC.

16           That's all I have on it. We'll open up the  
17 public hearing, if anybody wants to address it.  
18 No?

19           WAYNE TURETT: Well, I could address it.

20           MAYOR HUBBARD: Well, yeah, just come up  
21 to -- name and address for the record.

22           WAYNE TURETT: Wayne Turett, 746 Main  
23 Street.

24           So the maintenance I took out of the  
25 application. It was just my terminology was

1 incorrect.

2 I also lowered the drawings to 4 feet, so I  
3 changed that.

4 As far as where the dredge spoils go, I'm  
5 still working it out with Brookhaven. I will test  
6 the soil for that, but if it doesn't work in  
7 Brookhaven, I have to take it, I'm told, to  
8 Pennsylvania. So I will make sure that everything  
9 is aboveboard.

10 You know, I'm just an architect. This is  
11 all out of my depths, no pun intended, but I'm  
12 trying to -- I've been trying to do this for three  
13 or four years.

14 TRUSTEE CLARKE: It's been a while.

15 WAYNE TURETT: It's a long -- it's a long  
16 haul to get Army Corps, the DEC and New York  
17 State. To get DEC permit, I had to test for 150  
18 chemicals. So what they found was that of the 150  
19 chemicals they tested, one chemical was slightly  
20 elevated with mercury, and that's the rub on where  
21 to put it. Originally, I wanted to put it on my  
22 property, DEC wouldn't let that happen. So,  
23 basically, they said you can put it at an approved  
24 landfill. Brookhaven was suggested, I  
25 corresponded with them.

1           They do have, as well as New York State and  
2 EPA, has certain standards for leaching. So if  
3 the sample I get that I take and test for that  
4 leaching, if it matches the standard that are  
5 required, they'll be able to take it. If not,  
6 I'll have to take it to an approved landfill, and  
7 I'm told the closest is Pennsylvania. I have no  
8 idea what that costs. It's not going to be cheap,  
9 but that's the way it goes.

10           Is there -- are there any other questions  
11 that I can answer?

12           MAYOR HUBBARD: Okay. Any questions?

13           TRUSTEE CLARKE: When did you first start  
14 your application, Mr. Turett?

15           WAYNE TURETT: I started it like 2018. Last  
16 time I tried to apply here was, I think, 2019 or  
17 2020, and what happened was, is that my Army Corps  
18 of Engineer application was two weeks --

19           TRUSTEE CLARKE: Had expired.

20           WAYNE TURETT: -- overdue.

21           TRUSTEE CLARKE: Right.

22           WAYNE TURETT: It expired. So then I had to  
23 go back and do it again.

24           TRUSTEE CLARKE: I remember that.

25           WAYNE TURETT: And I couldn't, I couldn't

1 bring myself to do it. It took a while for me to  
2 get back into it.

3 TRUSTEE CLARKE: Well, the process has been  
4 so much and so long anyway.

5 WAYNE TURETT: Yeah, yeah. That -- you  
6 know, it is what it is.

7 TRUSTEE CLARKE: Yeah, that's --

8 WAYNE TURETT: And I certainly support, you  
9 know, good drinking water on Long Island, I don't  
10 want to pollute anything.

11 TRUSTEE CLARKE: Sure.

12 WAYNE TURETT: But I'm curious, if I could  
13 ask, the dredge that took place at the entrance to  
14 Stirling Harbor this past year, are there -- are  
15 there test results for the soil that they took out  
16 of there? Because I'm curious if they had the  
17 same issue that I did, but they put the spoils on  
18 the --

19 MAYOR HUBBARD: I think the issue is that  
20 the section that you plan on dredging has never  
21 been dredged before.

22 WAYNE TURETT: Right.

23 MAYOR HUBBARD: The other side was all just  
24 sand that had run from Sandy Beach down into the  
25 channel. And they picked it up, same as they had

1 done 20 years ago --

2 WAYNE TURETT: I see.

3 MAYOR HUBBARD: -- picked it up from the  
4 entrance of the channel and put it up into the  
5 wetlands.

6 WAYNE TURETT: I see, I got it.

7 MAYOR HUBBARD: And yours is kind of like  
8 undisturbed area, because that's never -- I don't  
9 believe it's ever been dredged before, not that I  
10 know of.

11 TRUSTEE PHILLIPS: No, it's -- as far as I  
12 know, it's --

13 WAYNE TURETT: No, I don't think it's been  
14 dredged, although the dock was rebuilt in 2002.  
15 There is a permit --

16 MAYOR HUBBARD: Uh-huh.

17 WAYNE TURETT: -- a whole slew of permits  
18 for that. And then, really, what happened, I  
19 think, since 2002 to now, it silted back up, and  
20 so that's why I thought it was dredged --

21 MAYOR HUBBARD: Okay.

22 WAYNE TURETT: -- it seemed dredged, but --

23 MAYOR HUBBARD: That's the best explanation  
24 I had at this point right now. The other stuff  
25 had been done previously and they just took it and

1 just moved it back up on the top.

2 WAYNE TURETT: Yeah, got it.

3 TRUSTEE ROBINS: Just curious.

4 WAYNE TURETT: Yeah.

5 TRUSTEE ROBINS: If you are not able to do  
6 this in Brookhaven and you do have to find out  
7 what it's going to cost you to go to Pennsylvania,  
8 would you abandon the project? I mean, is it  
9 going to be worth it to you one way or another, do  
10 you think, or --

11 WAYNE TURETT: I think it depends on the  
12 cost.

13 TRUSTEE ROBINS: I'm sure.

14 WAYNE TURETT: But I don't know. I'd like  
15 to have it, because right now I can't use my boat.  
16 It's sailboat and it sits on the bottom two hours  
17 on each side of low tide, so I can't move it, so I  
18 at least want to be able to do that.

19 TRUSTEE CLARKE: Yeah.

20 MAYOR HUBBARD: Okay.

21 ATTORNEY PROKOP: You said that you're  
22 taking something out of the application. Is  
23 that -- what did you mean?

24 WAYNE TURETT: Yeah. If you'd like, I could  
25 give you the new pages, the things that were

1 mentioned before, which was maintenance. I  
2 could -- I could hand you these.

3 TRUSTEE PHILLIPS: No, that's -- I think,  
4 aren't they supposed to go to the Village  
5 Administrator?

6 WAYNE TURETT: Okay.

7 TRUSTEE PHILLIPS: They need to go through  
8 the process. But, Paul, do you have a --

9 WAYNE TURETT: Whichever way you want it to.  
10 Do you want more than one copy?

11 ADMINISTRATOR PALLAS: No.

12 WAYNE TURETT: So I took out -- I took out  
13 maintenance dredging and I added something which  
14 said the spoils will be taken to Brookhaven  
15 Landfill or taken off of Long Island.

16 ATTORNEY PROKOP: So you took that out  
17 before -- when it was being considered by the DEC  
18 or after?

19 WAYNE TURETT: No, no, just based on the  
20 comments I got from --

21 TRUSTEE ROBINS: The CAC?

22 ATTORNEY PROKOP: Because the --

23 TRUSTEE PHILLIPS: The DEC?

24 ATTORNEY PROKOP: Maintenance is a technical  
25 term that's significant to the DEC. So if your --

1 if your application to the DEC was for maintenance  
2 dredge --

3 WAYNE TURETT: It was not.

4 ATTORNEY PROKOP: It wasn't, okay.

5 WAYNE TURETT: It was not. And then in the  
6 drawings, I changed it from 5 feet to 4 feet. But  
7 the DEC application did not say maintenance.

8 ATTORNEY PROKOP: Okay. But we have -- we  
9 have it as maintenance.

10 WAYNE TURETT: You do, yes.

11 ATTORNEY PROKOP: Dredging.

12 WAYNE TURETT: It's in there.

13 MAYOR HUBBARD: Okay. All right. Thank you.

14 WAYNE TURETT: Thank you.

15 TRUSTEE CLARKE: Thank you, sir.

16 MAYOR HUBBARD: Anybody else wish to comment  
17 on this public hearing?

10 328,000 for expanding the microgrid project, is  
11 that -- what percentage of that is paid for by the  
12 grant?

13 MAYOR HUBBARD: I'm sorry, I did not  
14 understand what you said, Randy.

15 RANDY WADE: I know. I'm sorry, I'm talking  
16 through fabric. The \$328,000 for the expansion of  
17 the microgrid --

18 MAYOR HUBBARD: Yes, okay.

19 RANDY WADE: -- area, what percentage is  
20 covered by the grant?

21 TRUSTEE PHILLIPS: None of it is.

22 MAYOR HUBBARD: None of that is covered by  
23 the grant.

24 RANDY WADE: So the Village wants to pay  
25 328,000? Is it -- is it because we'll get the

1 money back, or why?

2 MAYOR HUBBARD: No. It's to harden the  
3 infrastructure of what we're doing with the  
4 overall -- we service the customers down there.  
5 When the company is here in the Village doing the  
6 work, that's in addition to what was included in  
7 the original grant, because the grant won't cover  
8 work outside the Village. So we're doing the  
9 additional work, because they are paying customers  
10 of ours and they have been for many years, and  
11 we're just trying to harden the rest of the  
12 infrastructure throughout our service area, let me  
13 put it that way.

14 RANDY WADE: Okay. It's 328,000. That was  
15 in the budget already for expending that, or it's  
16 part of your capital and you don't have to bond  
17 for it, or how does that work?

18 TRUSTEE PHILLIPS: It's in the Electric Fund.

19 MAYOR HUBBARD: No. Paul, do you want to  
20 answer that, just --

21 ADMINISTRATOR PALLAS: Funds are available  
22 in the Electric Fund to pay for that portion of  
23 the project.

24 RANDY WADE: Oh, great. Thank you.

25 TRUSTEE CLARKE: You're welcome.


