## Parking Enforcement FAQs

### What do I do if I get a ticket?

If you've received a parking ticket in the Village of Greenport, you may pay online by visiting: <http://villageofgreenport.org/pay-parking-ticket-village-greenport.php>

Certified checks or money orders must be made payable to Southold Town Justice Court.

Please be advised, no personal checks are accepted.

*PLEASE DO NOT SEND ANY PAYMENT OR HEARING REQUESTS TO GREENPORT VILLAGE HALL. ALL TICKETS ARE PROCESSED THROUGH SOUTHOLD TOWN JUSTICE COURT.*

If you plead not guilty, you will be required to appear at Southold Town Justice Court for a hearing.

### What are the frequent violations issued in the Village of Greenport and how can I avoid them?

#### **PARKED LONGER THAN PERMITTED SCHEDULE**

The Village of Greenport enforces timed parking. Please pay attention to time limits and hours of restrictions when parking your car on Front Street, Main Street, First Street, Adams Street, Fourth Street MTA Lot, and designated spots in the IGA Parking Lot. Timed Parking IS NOT suspended on Sundays and Holidays.



### **VEHICLE PARKED OUTSIDE OF LINES**

All vehicles are required to park within marked lines wherever lines are painted.

### **PARKED OUTSIDE OF MARKINGS**

Vehicles that are parked outside of designated spots may be subject to a summons. Please ensure you check all markings to confirm you are parked in a designated spot.

### **STOPPING/PARKING AT CHARGING STATION**

Stopping or parking at the charging station located in the Adams Street parking lot shall be limited to vehicles that are authorized to charge - and are charging. Charging of an authorized vehicle is limited to a time of one hour. Vehicles in violation are subject to being ticketed and towed.



### **PARKED WHERE PROHIBITED**

Vehicles may only be parked where authorized. Please note that the following are not authorized:

**NO PARKING**

**NO PARKING THIS SIDE**

**NO PARKING HERE TO CORNER**

**NO STOPPING /STANDING/ PARKING**

### **UNINSPECTED / UNREGISTERED**

Vehicles parking on any streets and in any Municipal Lot in the Village of Greenport must display a current inspection sticker and valid registration sticker.

### **PARKED FACING WRONG DIRECTION**

Vehicles must be parked facing the direction of authorized travel.

### **PARKED ON SIDEWALK**

No person shall park a vehicle in whole or part on a sidewalk.

### **OBSTRUCT DRIVEWAY**

When parking, please ensure that your vehicle does not obstruct any portion of a driveway.

### **PARKED ON VILLAGE STREET DURING A SNOWSTORM**

When 2" or more of snow have fallen, motor vehicles must be removed from all streets within of the Village of Greenport. A vehicle found to be in violation of this law is subject to a \$100 summons for each day the vehicle remains on the street.



**What do I get when I search by ticket number?**

When searching for the amount owed on an individual ticket, the site will also tell you of any other tickets you owe in the Village of Greenport. Additional tickets are listed for the license plate associated to your search.

**Can I still pay on-line if my ticket is past due?**

Yes. If you search for a ticket that is past due, the late fee is already included in the price displayed to you in the search result. You do not have to add any penalties to the price displayed. If your ticket is not found in the system, please contact us at 631-477-0248 Ext. 212. Please have the ticket number, license plate and date the ticket was issued available.

**What if I fail to respond to a violation?**

If you fail to respond to a violation within 30 days of the date the summons was issued, penalties will begin to be added to the original fine.

**Can I be held responsible for tickets issued to a vehicle that I co-own, even though I do not use the vehicle?**

Yes. As a registered owner, you are liable for any tickets regardless of whether or not you were using the vehicle at the time the tickets were issued.

**What happens if I don't answer a parking ticket that was issued in the Village of Greenport?**

If you fail to answer a parking ticket that has been issued in the Village of Greenport, you may be classified as a scofflaw resulting in the denial of the renewal of your registration.

Additionally, the Village may file a civil judgement against you which may adversely affect your credit rating.
